3 To amend Section 27-13-121 of the Code of Alabama
4 1975, relating to motor vehicle insurance, to provide for a
5 reduction in the number of hours of instruction required to
6 complete a motor vehicle accident prevention course; and to
7 allow online instruction.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9 Section 1. Section 27-13-121 of the Code of Alabama
10 1975, is amended to read as follows:

11 "§27-13-121.

12 "To qualify for the insurance premium reduction
13 described in Section 27-13-120, the motor vehicle accident
14 prevention course shall be sponsored by the National Safety
15 Council, the American Automobile Association, or the ~~American~~
16 ~~Association of Retired Persons~~ AARP or shall be an equivalent
17 program course approved by the Department of Public Safety.
18 The program course shall consist of not less than ~~eight~~ six
19 classroom or online hours of instruction, the instructors for
20 the program course shall be certified by the sponsoring
21 entity, and the contents of the course shall be outlined by
22 the sponsoring entity."

23 Section 2. This act shall become effective on the
24 first day of the third month following its passage and
25 approval by the Governor, or its otherwise becoming law.
